Danny Johnson provided an overview of stakeholder engagement activities of 2014 that will help fuel the scope of work for the plan update. Mr. Johnson summarized the major talking points from breakout sessions at the July 2014 Joint BAC meeting and provided a summary of the August 2014 Governing Board meeting which included a panel discussion on integrated planning.

Sustainability Projects at Hartsfield-Jackson International Airport

Polly Sattler gave a presentation on the sustainability projects completed at the airport. She explained that the Mayor of Atlanta wants the airport to be one of the greenest in the world. The 2020 sustainability goals include dealing with emissions, energy, waste, water and green construction. Some examples included: switching to LED lights in places to say energy. For water conservation she talked about their projects for rainwater harvesting, filtering and slow release for the watering of plants. Another example for sustainability is the rental car center. The rental car center improvements have helped with emissions and traffic. The car wash captures and reuses 80% of the water used. There is a goal to reduce CO2 emissions by 20% by 2020 from 2008 levels. Many of the airlines ground vehicles have been switched to electric vehicles. A project in development right now is Green Acres. The goal for Green Acres is to take terminal food waste and compost it and use it for alternative fuel production or food production.
