Approve Meeting Minutes

2016 Year End and 2017 Budget Revision

Basin Advisory Council Operating Procedures Update

Mr. Andy Cornwell presented recommended updates to the Basin Advisory Council Operating Procedures. Highlights of the updated procedures include:

- The importance of a diverse membership is more specifically stated.
- The term for the BAC chairperson will be extended from 1 to 2 years taking effect following the 2017 fall election.

- The operating procedures will now allow for the formation of committees in each BAC in addition to the election of other officers as needed.
