Vice Chair Hendrickson presented the September 11, 2024, meeting minutes for approval. No revisions were offered. Ms. Jennifer Arp made a motion to approve the meeting minutes. The motion was seconded by Mr. Tony Carnell and passed without opposition.

Chairman's Update

Recognitions

2025 Finance Committee Membership

Treasurer Dr. Mark Berry presented the 2024 Year End Budget Revision. BAC New Member Approval

Vice Chair Hendrickson presented 19 applications for Basin Advisory Council membership. The Executive Committee voted to approve the members. The Executive Committee is responsible for approving new BAC members, therefore there is no required action of the Board.

Staff Updates

Education and Outreach

Ms. Justine Schwartz provided an overview of ongoing education activities and events including the announcement that the District was awarded the 2024 WaterSense Sustained Excellence Award. She also announced the winners of the 2024 Water Reflections Calendar Contest. The 2024 Middle School Essay Contest was a success with over 800 essays submitted on a variety of topics such as "Importance of Water to our Region," "Compare and Contrast Water Careers," and "The Importance of Water to Recreational Activities." Winners will be announced at a reception at the State Capitol on December 17, 2024.

Sanitary Sewer Overflow Trends / WIPPES Act

Mr. Rob Sherrod presented research on sanitary sewer overflow trends in metro Atlanta, as well as proposed congressional legislation that would change the labeling of wipes marketed as "flushable" called the "WIPPES Act." Mr. Sherrod encouraged anyone interested in moving this this legislation forward to reach out to their elected officials.

Data Centers Update

Ms. Celine Benoit provided an update on data center trends in the region and feedback received from the Atlanta Regional Commission Governing Board.

2028 Plan Update

Mr. Danny Johnson provided highlights of the District's planning activities related to the next 5-year update to the Water Resources Management Plan due in 2028.
