Forsyth County Permit Ruling

Tim Perkins, Director of the Forsyth County Water and Sewer Department presented an overview of their permit application process for a new discharge to the Chattahoochee River. This included a history of the process beginning in June 1996, an overview of the recent ruling in which Forsyth's permit was challenged and the need for clarification of the existing anti-degradation policy.

GA EPD's Anti-degradation Policy and Analysis Guidance Manual

Jane Hendricks with the Georgia Environmental Protection Division presented an overview of the DRAFT changes to the State's Anti-Degradation Policy. This presentation included an overview of the proposed changes and a look at some of the public comments received during the public comment period. The DRAFT policy will be presented to the Department of Natural Resources Board on Tuesday, August 23, 2011 and then it will be sent out for public review.

Final F.O.G. Materials

Corey Babb presented an overview of the Fats, Oils and Grease (F.O.G.) education materials. He stated that 100,000 F.O.G. doorhangers had been printed and were currently being distributed by the Atlanta Apartment Association. Mr. Babb will obtain distribution totals and locations to provide to the education/outreach staff of the local governments involved.
