Summary/Final Minutes

August 21, 2019

The Metropolitan North Georgia Water Planning District Technical Coordinating Committees for Water Supply and Water Conservation and for Wastewater held a joint meeting on Wednesday, August 21, 2019 at 10:00 p.m. in the Harry West Rooms at the Atlanta Regional Commission office in Atlanta, GA.

Andrew Morris with the Metro Water District welcomed participants. Following brief introductions, the business of the agenda was conducted as follows:

Public Comment Period - No Participants

Ms. Kelsey Waidhas with the Metro Water District presented an overview of the new requirements for risk and resilience planning under the 2018 American Water Infrastructure Act.

Ms. Allie Orrego with the Metro Water District announced the next AMI users group meeting for September 4, 2019 for utilities interested in learning from others in the development and management of an AMI system.

Mr. Morris presented on indoor water use in new and recently renovated homes.

Mr. Danny Johnson presented an overview of research on implications of conservation and efficiency to wastewater treatment and collection systems.

Mr. Johnson presented an update on recent efforts to engage stakeholders and collect data related to recent changes in biosolids management.
