An astounding 72% of the District's total public water supplies are withdrawn from the Upper Chattahoochee River Basin. Environmental planning criteria are in place to safeguard the natural resources associated with the river, including wetlands, stream buffers, groundwater recharge areas, and protected rivers.

The North Chattahoochee River has left an indelible mark on the history and development of Fulton County. Its contributions are multifaceted, from protecting endangered species and influencing land use patterns to supporting vital fisheries and providing a critical drinking water supply.
